This indicates that the quality of student character education is very important to be improved.

There are two aspects of activities that are the core of moral education, the first is to guide the conscience of students to grow more positively gradually and the expected result is a change in the personality of students from the original egocentric to altruistic. Along with the fruit of this process of cultivating positive values, moral education seeks to erode and keep students away from bad traits and values.

Meanwhile, in terms of terminology, value is an empirical quality that is sometimes difficult or impossible to define. The role of Islamic education is very much needed in instilling discipline values, where it is an era full of challenges faced by today's students, students become confused and wonder what they should do and how to behave.

Increasing the value of student discipline in education must start from school at the elementary level (SD-SMP). The success of discipline education at that time will be the foundation to build the discipline of students at the level of education above it and also in community life in general. For this reason, the role of schools is very important, schools as educational institutions are also responsible for improving discipline in students. Polman, students should arrive before the hour At the beginning of learning, students must dress in school uniforms with polite and clean manners, students must wear clothes in physical education classes Sports uniforms, classes begin and end with prayer and solemnity to teachers and students are obliged to maintain classroom cleanliness.

The occurrence of undisciplined behavior in the school shows that there has been a serious problem in the character of discipline. The emergence of undisciplined behavior indicates that knowledge related to discipline obtained by students at school does not have a positive impact on improving the behavior of students' discipline values. It could be that Islamic education has only been a pattern of knowledge stages. It has not yet come to feelings and behaviors with character, with problems like this, of course, all of them require serious efforts to prevent and handle.

SMP Negeri 2 Tinambung Kab.Polman which is the choice for the author to conduct research on improving student discipline, considering that this school in its curriculum integrates Islamic educational values in it, this school also excels in Islamic knowledge and values, so that students in addition to mastering science also have the value of religious discipline and can apply the value of discipline wherever they are.

METHOD

RESULT AND DISCUSSION

Improving student discipline through the implementation of Islamic educational values at SMP Negeri 2 Tinambung is carried out through scheduled congregational prayers, reciting, filling out students' Religious Activity Sheets, memorizing short letters, and praying. The supporting factors for the implementation of Islamic educational values through habituation activities in elementary schools are supported by the existence of facilities, infrastructure, parental cooperation, and also the behavior of school residents. The implementation of discipline values applied in schools is mostly inherent and indirectly the students can

automatically follow and obey all applicable rules, which is very beneficial for students to feel the benefits of running it because it can help them become better students if they are at school and good children if they are at home in carrying out their various activities. This is in accordance with the theory that explains that discipline is self-awareness that arises from the mind of each person to follow and obey the rules that apply in the environment which raises the awareness that if he is well disciplined, it will have a good impact on his success now and in the future.

The implementation of Islamic educational values that are applied also has a goal which is none other than for students to improve their self-discipline well wherever they are, both in the school environment, family environment, and community environment. This is in accordance with the theory that explains that the discipline that students have will help students in their daily behavior, both at school and at home, students will easily adjust themselves to the environment they face. Religious activities implemented at SMP Negeri 2 Tinambung include dhuha prayers, congregational prayer prayers, reading the Qur'an, which in its implementation is enforced scheduling time for each class, reciting activities, memorizing short letters, filling out the Student Religious Activities Sheet, and praying before and after learning. This is in accordance with the theory that one of the most important worship activities in Islam is prayer, where prayer consists of prayers that are obliged, namely dawn prayer, high prayer , asr prayer, maghrib prayer, and isha prayer, while there are also sunnah prayers such as dhuha prayer, tahajud prayer, witir prayer, and other sunnah prayers.

The supporting factors obtained by the researcher include the availability of several facilities in carrying out Islamic educational values activities for students, the availability of infrastructure as a support for the availability of facilities in schools, the availability of bridges that connect to communicate between the school and students' parents in supporting the Islamic educational values activities of students. And do not forget the school atmosphere, which in this case is the behavior reflected by all school residents. This is in accordance with the theory that states that supporting factors in habituation activities of Islamic educational values can come from external factors, namely factors that can be in the form of facilities and infrastructure, environmental situations, be it the school environment, family environment, or the surrounding community environment. Facilities are tools or facilities that are used directly for the sustainability of an activity. This is in accordance with the theory that means are equipment and equipment that are directly used in the process of an activity. Where the facilities available in this elementary school include the Quran, religious books/books, prayer tools, carpets, benches, classrooms, prayer rooms, libraries, and gazebos. This is in accordance with the theory that facilities include buildings, classrooms, chairs and tables.

Infrastructure is a public facility that supports the main facilities in the activity process. This is in accordance with the theory that states that infrastructure is a basic completeness that indirectly supports the implementation of the activity process. The infrastructure in the elementary school which is a supporting factor is the school yard, the existence of paved roads so that it is easy to access, and also the existence of electricity. This is in accordance with the theory that infrastructure includes school yards, school gardens, school parks, and roads to school.

In addition to supporting factors of facilities and infrastructure, there are also supporting factors that come from the home environment of students, the home environment referred to here is the involvement or participation of the parents of the students themselves. This is in line with the theory that parental involvement has a considerable influence on success. For this reason, one of the efforts made by SMP Negeri 2 Tinambung is to hold communication between the school and the parents of students through whatsap groups on social media, where the purpose of holding the whatsap group is expected that the school can communicate about its students as well as provide directions to parents to be able to support and also supervise children when the child is in the home environment so that what has been worked on at school will

remain embedded until they are in an environment outside of school.

The last supporting factor in elementary school is the supporting factor that comes from the school atmosphere. This is in accordance with the theory that states that the role of schools in improving discipline must be actualized effectively by developing all components in schools with the involvement of every school citizen starting from school culture to classroom climate. The school residents referred to in SMP Negeri 2 Tinambung are all people involved or who are in the school which includes students, teachers, principals, school guardians, and so on. In addition, a pleasant school atmosphere will later make students also feel happy when they are at school and when doing all the activities that are applied at school.

CONCLUSIONS

The character of Independence of I'dadiyah Students Campus 1 of the DDI Mangkoso Islamic Boarding School obtained from the results of the research is able to manage themselves, be responsible for responsibilities and obligations, exercise self-control with their own initiative, be able to face and solve problems, be obedient to discipline, have confidence, do not depend on other fellow students, and have strong self-confidence.

RECOMMENDATIONS

For Teachers. Especially teachers who teach at SMP Negeri 2 Tinambung should enrich their knowledge and skills. Mainly related to their respective duties. Increase insight and fully realize the duties and responsibilities charged in coaching and improving student discipline as expected.

For parents. Especially parents of SMP Negeri 2 Tinambung students to continue to supervise, control and teach habituation to children about Islamic educational values and practice them in daily life in order to improve discipline wherever they are.
